What do you need to know about the Updated CDFM Exam? by Heather Ireland

ASMC's certification team, CDFM certificants, and subject matter experts have been working diligently to evolve these exams in recent months. We know you've got questions – luckily, we've got answers...



How long will I be able to take the old exams?

The "old" and "updated" exams will run concurrently from May 29, 2024, through September 30, 2024.

Is there a transition plan for candidates who have already started preparing for the previous version of the exam?

Any candidates who started preparing for the previous exams can test for those exams until September 30, 2024. After this date, only the updated exams will be available.

Is there a new format for the exam, such as different question types or a different number of questions?

No, there are still 80 multiple-choice questions on each exam.

Greetings members,

Many of you have heard the great news about our organization! For those who have not heard the great news! I am proud and excited to announce that the American Society of Military Comptrollers (ASMC) is now The Society of Defense Financial Management (SDFM). Wow, this was an exciting moment at the National PDI 2024 to learn about the updated name. Mr. Rich Brady, CEO of SDFM, unveiled the new name and brand to over 5,500 in-person and 1,500+virtual attendees on 28 May 2024 during the opening session, the first day of the PDI. SDFM is committed to its member and their success.

I learned that "timing" is essential when making decisions for such a moment like this. Being a global organization, the SDFM National leadership believed this was the right time to update the name and brand to reflect the continuous evolution in the financial management profession that we serve in DoD. At the PDI, Mr. Brady communicated that "the defense financial management has grown and evolved remarkably in recent decades, and this change reflects the diversity we have in the profession today" (sdfm.org). Also, the re-branding allows the organization to "prepare for the next generation of Defense Financial Management professionals which reflect the boarder audience currently served" (sdfm.org/PPT).

As this re-branding is new for many of us, this is not the first time the name has changed to allow for membership growth, innovation, expansion opportunities, and meeting the demand of the financial management (FM) profession in the defense industry. For seventy-six years, our national organization has been in existence. In 1948, the Society of Military Accountants & Statisticians was founded in San Antonio and only open to active-duty officers. In 1955, the founders decided to expand membership to all DoD and Coast Guard (FM) personnel, and civilian contractors and updated the name to the American Society of Military Comptrollers until the recent update, now the Society of Defense Financial Management (SDFM). Our organization has always answered the call to remain relevant in the FM industry. Although the name has changed, the mission has

SDFM will continue to bring "Unity in the FM Community" as this was the theme for this year's National PDI 2024 through relevant FM topics, learning and development, innovation, upskilling, educational opportunities, certifications, and more. For instance, the National PDI attendees, both inperson and virtual, had the opportunity to select from over 100+ sessions to attend to earn CETs.
